#### BISTRO RESTAURANT AND ALCOHOL LICENCE:

I am sure you would notice that a public notice displayed outside the property for an application of Alcohol License for the premises. This was instigated by the McCarthy Stone catering department with the idea of installing a vending machine in the Bistro selling alcohol. Donna Bailey (the area manager) is currently seeking clarification of the exact details and I am sure a
